

**SHAW'S & STAR MARKET GRAND SLAM SWEEPSTAKES
OFFICIAL RULES AND TERMS AND CONDITIONS**

1. **PROMOTION PERIOD:** The Shaw's & Star Market Grand Slam Sweepstakes (the "**Sweepstakes**"), including the Rewards Program ("**Rewards Program**") begins 12:00 AM (midnight) Eastern Time ("**ET**") on April 3, 2026 and ends 11:59 PM ET on September 24, 2026 (the "**Promotion Period**"). Points that have been earned prior to the Purchase Period will be eligible also. Points for Point Entries must be redeemed by 11:59 PM ET on September 30, 2026. The Promotion consists of a series of random drawings which includes six (6) entry periods (each, an "**Entry Period**"), each including one (1) First Prize, one (1) Second Prize and one (1) Third Prize, with the exception of Entry Period 4, which will only have one (1) Second Prize and one (1) Third Prize (each, an "**Entry Period Drawing**"), and the Grand Prize Drawing ("**Grand Prize Drawing**"), as defined in the chart below in Rule #4.

"Sweepstakes" and "Rewards Program" will be collectively referred to as "**Promotion**".

2. **ELIGIBILITY:** Open to legal U.S. residents, residing in Massachusetts, Maine, New Hampshire, Rhode Island and Vermont ("**Eligibility Area**") who shop at stores listed in Exhibit A, and are eighteen (18) years of age or older at time of entry ("**Entrant**"). Employees of Albertsons Companies, Inc. ("**Sponsor**"), Don Jagoda Associates, Inc. ("**Administrator**"), and their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively "**Released Parties**") and the immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each, are not eligible. Void outside Eligibility Area and where prohibited. All applicable federal, state and local laws and regulations apply.

3. **HOW IT WORKS/REDEEMING POINTS FOR SWEEPSTAKES ENTRIES:**

- a. **VIA A PURCHASE:** During the Promotion Period, eligible Entrants who are Shaw's for U™ or Star Market for U™ members can earn points ("**Point**" or "**Points**") with purchase of any qualifying product ("**Participating Products**") at any participating Shaw's and/or Star Market stores listed in Exhibit A. Earn Points by shopping at store locations or by shopping through mobile apps or websites. To receive Points on purchases, Shaw's for U™ or Star Market for U™ members must use their registered mobile number or scan the Member Card in the Deals & Delivery mobile app at checkout:
 - i. Earn 1 Point for every \$1 you spend on groceries.
 - ii. Earn 2 Points for every \$1 you spend on gift cards.
 - iii. Earn 1 Point for every \$1 you spend on qualifying pharmacy purchases

Entrant may also utilize Points already accumulated prior to the Promotion Period. Participants who are Shaw's for U™ or Star Market for U™ members can also earn 4x points by purchasing any participating products ("**Participating Product/s**"). Participating Products that are eligible items can be identified by a shelf tag in-store or noted as "clippable" in the Shaw's for U™ or Star Market for U™ apps or noted on the Grand Slam Summer Sweepstakes Landing Page shaws.com/grandslam or starmarket.com/grandslam. Purchase of eligible items will result in the Point multiplier for every dollar spent on eligible Participating Products. Full list of 4x Points Participating Products is available at shaws.com/grandslam or starmarket.com/grandslam. Members must download the 4x digital for U™ coupon to their account prior to in-store or online purchase. Points earned in each transaction will equate to the number of Participating Products purchased, while supplies of Participating Products last. There is no limit to the number of Points you can accumulate throughout the Promotion Period. Points

Expiration Date: Points do have an expiration date and will expire within 2 calendar months, including the month they are earned. For example, Points earned in April will expire at the end of May which is the end of the 2nd calendar month after they are earned. Entrants may use 50 Points to earn one (1) Sweepstakes entry into the Entry Period Drawings, as defined below (the “**Points Entries**”). Entrants will visit their Shaw’s for U™(www.shaws.com/rewards/dashboard) or Star Market for U™ (www.starmarket.com/rewards/dashboard) account (“**Account**”), during the Promotion Period to redeem their accumulated Points for grocery rewards or Points Entries. Entrants may redeem their Points for Points Entries at any time during the Promotion Period and Points must be redeemed by 11:59 PM ET on September 30, 2026. There is no limit as to how many Points Entries may be redeemed. Points will be subtracted from Entrant’s Shaw’s for U™ or Star Market for U™ account each time and simultaneous with when Entrant redeems Points for Points Entries.

Entrant must have sufficient Points available to redeem for Points Entries selected. Entrants may not assign or transfer any Points. No cash will be exchanged for the unused portion of any Entrant’s Points. Once Points have been redeemed for Points Entries, they are no longer valid for any subsequent redemption, and they may not be returned or refunded to an Entrant’s Account for any reason. Sponsor reserves the right to invalidate Points from an Entrant’s Account if it determines in their sole discretion that such Points were improperly credited to such Account or were obtained fraudulently or otherwise in violation of these Official Rules and Terms and Conditions. Points are not redeemable for cash, transferable or assignable for any reason. The sale, barter, transfer or assignment of any accumulated Points, other than by Sponsor, is strictly prohibited. Any Points which Sponsor deems in its sole discretion to have been transferred, sold, bartered or assigned in violation of the Rewards Promotion’s Terms may be confiscated and/or cancelled. The "Grand Prize Mailed Entries", the "First Prize Mailed Entries", the "Second Prize Mailed Entries", and the "Third Prize Mailed Entries" will be collectively referred to as the "**Mailed Entries**". Mailed Entries must be postmarked by the Mailed Entry Postmark Deadline and received by the Mailed Entry Deadline indicated in the chart below in Rule #4, to be included in that Entry Period's drawings. All Mailed Entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending will not be deemed to be proof of receipt by Sponsor. "Points Entries" and "Mailed Entries" will be collectively referred to as "**Entries**".

4. **RANDOM DRAWINGS, PRIZES, APPROXIMATE RETAIL VALUES ("ARVs") AND WINNER NOTIFICATION:**

One (1) winner for each applicable prize listed below, per Entry Period (except for the Grand Prize Drawing, which will have 10 Grand Prizes) will be randomly selected on or about the Random Drawing Dates indicated in the chart below, from among all eligible Entries received for each Entry Period Drawing. Odds of winning depend upon the number of eligible Entries received for each Entry Period Drawing. Drawings will be conducted by Administrator, an independent judging organization, whose decisions are final and binding on all matters relating to this Promotion. Grand Slam Challenge (“Challenge”): All Grand Prize winners will have one (1) opportunity to win groceries for a year, awarded in the form of fifty-two (52) \$100 Shaw’s gift cards if, at the Game the winners are in attendance at, the designated Boston-based professional baseball team hits a grand slam home run against the Chicago based professional baseball team. For purposes of this Challenge, a grand slam home run is defined as an official grand slam home run as ruled by the league while there are base runners on all (3) bases – resulting in (4) runs batted in for the batter on the play.

- The hit must be officially ruled as a 4-run grand slam home run in the box score and official statistics of the applicable league.
 - i. Inside the park home runs will be eligible to contribute to the winning grand slam home run provided there are no recorded errors committed on the play, and the hit is officially ruled and recorded as a home run by the league.
- If the Game in which the designated team hits a grand slam home run is cancelled for any reason prior to becoming an official game, all statistics are removed from the official score book and no prize claims will be acknowledged for that Game.
- Sponsor reserves the right to reschedule the Grand Slam Challenge to an alternate game date if an assigned Game is cancelled, suspended or if tickets are unavailable for any reason.

5. **GENERAL RULES:** By participating and/or redeeming Points for Points Entries and/or submitting Mailed Entries, Entrants agree to be bound by these Official Rules and Terms & Conditions ("**Terms**") and the decisions of the Administrator/Sponsor. The Sponsor reserves the right in its sole discretion to disqualify any individual that tampers or attempts to tamper with the Promotion process or website; violates these Terms; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. In such event of early termination, Sponsor shall give notice at least three (3) days prior to the date that such termination becomes effective via email notification, during which time Entrants may still accrue and redeem Points for Points Entries and all Mailed Entries will be included in the applicable drawings, as long as the Mailed Entries are received by Section 4's applicable Mailed Entry Receipt Deadline for the such Entry Period. All Points must be redeemed prior to the effective date of termination. Sponsor is not responsible for any typographical or other error in the printing of the Promotion materials. Sponsor and Released Parties shall have no liability or responsibility for any claim arising in connection with participation in the Promotion, any Points Entries awarded or Mailed Entries submitted.
